

## **CIRCUIT OF THE AMERICAS RV GOLF CART/ATV REGULATIONS**

The information listed within provides guidance regarding the valid usage of Golf Cart or ATV type vehicles (“CARTS”) at COTA Outside of the RV Areas. Operators of CART’s understand that they do so at their own risk, and will relieve and hold harmless COTA for any and all debts that might occur from theft, accidents, and/or injuries involving the use of the CARTS. These regulations have been designed to provide a safe and friendly environment for all persons attending events at COTA. Thank you for your cooperation.

**ONLY CARTS REGISTERED WITH COTA AND RECEIVING AN EMBLEM OR RENTED FROM KC GOLF CARTS MAY BE OPERATED OUTSIDE THE RV GATES. Registration of personal CARTS or requests to obtain a KC Golf cart can be obtained by emailing [andy@kcgolfcartco.com](mailto:andy@kcgolfcartco.com) at least ten (10) days in advance of a race.**

**THERE WILL BE A \$50 REGISTRATION FEE FOR ANY GOLF CART/ATV NOT RENTED FROM KC GOLF CARTS.**

- Only validly-licensed drivers who are eighteen (18) years of age or older are allowed to operate Cart;
- CART credential must be displayed on the hood/windshield of the CART. Credentials wrapped around the steering wheel are not acceptable;
- Pedestrians have the right of way; be courteous at all times;
- DO NOT park Cart in unauthorized areas of COTA property;
- DO NOT leave Cart unattended unless the ignition key is switched off and removed and secured by lock and chain;
- DO NOT exceed the maximum passenger or weight capacity of Cart or otherwise operate contrary to manufacturer’s instructions;
- DO NOT allow passenger(s) to sit on or about areas on Cart not specifically designed for seating including, but not limited to, the front cowl or in cargo box;
- DO NOT allow passenger(s) to stand while Cart is in operation;
- DO NOT use cellular phones or personal data devices while operating Cart;

- DO NOT operate Cart while under the influence of any quantity of alcoholic beverages or any substance which impairs your ability to drive, whether or not prescribed by a physician;
- ALWAYS ensure passengers are seated and ready before operating Cart;
- ALWAYS maintain a safe and cautious speed during operation. Do not suddenly swerve except in an emergency. The maximum speed limit on COTA property is 10 mph unless otherwise posted.
- ALWAYS use EXTREME CAUTION in highly congested areas, including but not limited to hospitality and display areas, concessions areas, souvenir areas, crosswalks, entrances to infield, etc., and other areas used by pedestrians;
- ALWAYS use headlights at night;
- ALWAYS report any accidents or incidents Cart is involved in to COTA Security or police at the time of occurrence.
- Carts are prohibited in the following public areas when gates are open:  
Main Grandstand, Grand Plaza and Pit Lane
- Do not operate any carts outside COTA premise including COTA Boulevard
- Carry and transport cargo only in approved areas of the cart
- Refueling carts is not the responsibility of COTA
- COTA is not responsible for lost or stolen carts

**Violation of these regulations will result in the Golf Cart/ATV being impounded for the remainder of the event, revocation of the Operating Permit and possible expulsion of the operator from the property with NO REFUND. COTA IS NOT RESPONSIBLE FOR ANY ACCIDENTS-INJURIES-THEFT ASSOCIATED WITH THE USE OF A GOLF CART/ATV AT COTA.**
